# A Contribution from a Member:

#### <u>JUST PRAY</u>

HAPPY NEW YEAR 2014

In today's suffering economy, everyone is looking for something that is cheap or free. I'll tell you what's cheap. Talk! Talk is cheap. Don't just SAY you're going to pray. Do it! It's free! Prayer costs us nothing, and it is priceless!

"I'll pray later." "I'll pray after I do these dishes."
"I'll pray when I get into bed." Sound familiar? If
I were giving a lecture in an auditorium, I am
certain that I would see many people's heads

nodding in agreement. Is yours? Do you think that you got gypped of the faith gene???

Find time to pray. The disease of addiction is a tri-fold disease. Wait a minute, did I hear someone mutter, "Disease, my foot!" I understand that this concept is hard to grasp. Before praying about your "disease," let's first believe that it IS a "disease."

You know how insurance relentlessly looks for a way out of covering your butt for something, right? Well, they cover inpatient and outpatient treatment for substance abuse, correct? Hmmmmm.....interesting. The disease of addiction is not visible once a person gets on a path of solid recovery. There are no bandages, crutches, or peeling skin like the disease of leprosy, so an alcoholic or drug addict can go unnoticed in a crowd. Unbeknownst to all, this individual is not cured and finished. Treatment is ongoing, incorporated into the person's lifestyle. He/she must nurture 3 components, namely physical, mental, and spiritual. This is because his/her disease is one that affects Body/Mind/Spirit. Just as one who suffers the disease of diabetes must take insulin shots for daily reprieve, alcoholics and addicts must take daily care by checking in with self, ultimately checking in with a Higher Power of their choice and attending self-help meetings to connect with likeminded people.

Higher Power is defined or referred to as "A Power Greater than Oneself." For me, this writer, it is God.

Pray. Just Do It. Like the Nike ad. There are three compartments. TRI-fold! Not one. Not two. But three. Don't forget to pray. The spiritual component is easily put off. It is resisted. It is postponed or procrastinated. JUST DO IT!

The physical aspect is bold and nags at one's body. We get physical cues when hit by bodily



conditions of hungry, angry, and tired. It is recognized and one will eat, use calming techniques, or get some rest. The mental aspect is also pretty apparent when one finds themselves obsessing about something or gets swallowed up by cues of emotional upset (fear, worry, despair, shame, guilt). It, too, is recognizable and one will use tools learned to redirect and recommit to sobriety. But the spiritual aspect is quiet and obscure. Many report total unawareness of being spiritually bankrupt. Many report knowing something is wrong, or just "not right," but are unable to put their finger on it. When we stray and forget to pray or refuse to pray, we become spiritually sick. It would be much easier if we had an angel who would periodically tap us on the shoulder and say, "Time to pray." "Time out." All components must equally be taken care of. If not, the untreated alcoholic or addict will be abstinent, but certainly not WELL.

To deny yourself this component of care, is to deny yourself a basic, essential need. It is not a luxury or a want. It is a need. JUST PRAY.

Why do many of us fall short of supplying this need to ourselves? Perhaps because of our need for concreteness. Tangible. Visible. Scientifically proven. I understand. But start small. "Act as If." As I have heard said before, I would really rather believe with blind faith in a Higher Power and find out the non-existence, than disbelieving....... and finding out in the EXISTENCE!

Take a nap if you are tired. Eat a snack if you are hungry. Drink cool water, if you are thirsty. Call a friend if you are lonely. And PRAY. Pray if you are needy or if you are grateful. Pray if you are hurting, and pray when you feel your heart rejoicing. JUST PRAY.

It's time to believe. The power of prayer is not to be pooh-poohed. There is belief that what happens in one's mind and soul is as important as what happens on a cellular level. Prayer and meditation change brain activity and improve immune responses. The neurotransmitter activity in the brain is carefully being looked at scientifically. It has been proven that prayer can lower one's heart rate and blood pressure, obviously, reducing one's response to stress.

Folks at Harvard Medical School report that people who pray tend to enjoy a greater psychological well-being and have less depression than those who do not. Now medical schools in our country offer courses to teach students how to provide this type of prayer-care. I, personally, am convinced that praying improves people's recovery.

Tap into your own personal ability to communicate with a Higher Power. Whether your Divine source is called God, Allah, Mother, or any other name, this relationship should be nurtured. Soon you will be arriving at your "most magnificent self." Your chosen source will have time to revel in the joy of hearing from you. Or, if you like, simply say nothing. Just sit and be with your Higher Power. Be quiet as a giraffe. A giraffe has no vocal cords!

Before I close, I would like to reiterate three things. Here they are:

PRAY!

PRAY!

PRAY!
