**Some not so good news:** we have [or soon will have] the following District 13 AA service vacancies:

- **DCM** [District Committee Member] - since Lou H., Sr. is 'rotating out of his 2-year term;
- **Alternate DCM** - position vacant for some time now [fills in when DCM is unavailable];
- **CPC/PI** [Cooperation with Professional Community/Public Information] also too-long vacant; we need to fill this service position, e.g. upcoming mailing of AA meeting lists to hotels/motels;
- **Records Keeper** – **Paul G's** 2-year term ends later this year; a replacement will be needed;
- **Treatment** - several members have expressed interest in serving in the Treatment position;
- **Special Needs** - a very rewarding opportunity to be of AA service - too often overlooked;
- **Corrections** - vacant **far too-long** - we **really** need to fill this important AA service position. [Please, I ask you, see a personal observation from the Editor on page 6 of this Newsletter.]

Copies of the January 2<sup>nd</sup> meeting minutes were provided to all attending, reviewed and approved;

Copies of the March 6<sup>th</sup> Treasurer's Report were provided to all attending, reviewed and approved. [copy included in confidential/members' version of this Newsletter. It shows how limited the funds are for District 13 AA service work and why member and Group contributions are so important.

Remember, proposed AA service expenditures are discussed and voted on at our District meetings. **Each Group has a vote.** That's just one reason why attendance at District 13 meetings is important.

At the March 6<sup>th</sup> District 13 meeting, DCM Lou H., Sr. reported on recent and upcoming AA events:

On February 22<sup>nd</sup> thru 24<sup>th</sup>, Area 48 AA members participated in a multi-States Northeast Regional AA Service Assembly [NERAASA] at which over 800 AA volunteers shared ways to better provide AA service to current members and those 'yet to find the rooms.' Possible restructuring of AA's General Service Office and Grapevine was discussed and will be examined at the General Service Conference.

On March 6<sup>th</sup> thru March 8<sup>th</sup>, members staffed an AA information/resource table at the New York Association of Drug Treatment Court Professionals in Saratoga Springs. Area 48 AA volunteers were there to help better inform the hundreds of participating professionals in these fields on what AA is, does, and does not do - and how the AA Program can be a life-saving answer for some of their 'clients'.

On Saturday, March 23<sup>rd</sup>, HMB Area 48 held its Day of Sharing/Delegate's Day in Hudson, NY. At that event, AA members provided feedback to our Delegate Keith D. as he prepares for the annual United States and Canada-wide AA General Service Conference to be held in NYC 4/21-4/27.

On Saturday April 20<sup>th</sup>, Area 48 will host the 'Corrections Connection,' an event bringing together officials and staff from New York State's correctional facilities and AA members already in, or interested in, AA service work in these New York State correctional facilities. Get details on this important event, being held in Rensselaer, in Area 48's March Newsletter - or see the enclosed flyer.

Contact our DCM Lou H., Sr. to learn how you can bring an AA meeting into NY State correctional facilities [in Comstock in District 13] or Washington or Warren County jails, even if just once a month.

On Sunday May 19<sup>th</sup>, Area 48 holds its Assembly at which Delegate Keith D. will provide a full 'report-back' on the United States and Canada-wide General Service Conference. We'll have details on that Assembly in next Month's Newsletter but see next item on the General Service Conference.

### **Here's something really important we ask each AA Member and Group to consider:**

At the AA General Service Conference, Keith will join with the 92 other elected Delegates serving the almost 64,000 Groups and 1.4 million AA Members in the U.S.A and Canada for this intense, week-long work effort at which the Conference starts the rigorous process of taking its own AA Inventory. There will be major discussion on possible AA restructuring to better serve current and new members.

**Keith has asked for input from all Members, Groups and Districts** to help him in this serious Conference effort to ensure that AA remains strong for future generations. You can tell Keith anything you believe is important to AA - today and in the years ahead - for the home group and AA as a whole.

Keith even prepared a Delegate's Questionnaire you can use to tell him what you think is important. We distributed copies at the 3/6 District 13 meeting and e-mailed copies on 3/11 to all members on our District 13 e-mail list. **If you still need a copy, please contact Newsletter Editor** [see page 5].

Keith needs your input by April 14<sup>th</sup> latest so he has time to reflect and prepare for the Conference. You can give your info to him personally at the April 14<sup>th</sup> HMB Area 48 Fellowship Day in Utica or by e-mail to [HMBArea48Delegate@hvc.rr.com](mailto:HMBArea48Delegate@hvc.rr.com). **Please take this opportunity to help AA.**

**There are 60 Groups in District 13 now with 80 AA meetings each and every week.**

**District 13 is deeply grateful to the Groups and Members who contribute to our AA service work.**

The Treasurer's Report above does show, however, that the District currently is below its prudent reserve. Paul G. also noted recently that total contributions to GSO last year equaled only **16 cents per AA member!**

**Times are tough but AA really could use your help!!** All contributions are acknowledged by letters from District 13, Area 48 and GSO. District 13 also lists contributions in its Treasurer's Report and Newsletter.

As possible help to members and Groups, it was voted at prior District meeting to include the addresses for mail and contributions in newsletters & meeting lists. Historical contribution share has been 60% District; 30% Area & 10% GSO.

### A personal observation from the Editor:

At the March 23<sup>rd</sup> Delegate's Day, the **Grapevine** table had a great assortment of books, CD's and other wonderful items published by the Grapevine [see catalog at [www.aagrapevine.org](http://www.aagrapevine.org) or get a free catalog by calling 800 631 6025. You also can get a mailed or e-mailed subscription by calling that same number.]

At the table, I bought [\$1.50] a facsimile of the first **Grapevine** - Volume 1, No. 1 - published June 1944.

That same week, the April 2013 issue of the **Grapevine** arrived in the mail. Yes, almost 70 years later, **Grapevine** staff still works hard to truly sustain "**AA's Meeting in Print.**" And, its cover page title:

*"Just Released, What Now? Leaving a treatment program or institution can be overwhelming. AA can help"* and with a special section on *Bridging the Gap* - that 'slippery slope' time for a newcomer after leaving but before he or she 'gets connected' with local AA members and a home group. Powerful reading!

Also last week, I received a copy of **Box 459**, AA's General Service Office quarterly publication on matters of wide interest to AA members [free by e-mail from [www.aa.org](http://www.aa.org) or by mail [just \$3.50 a year].

And which article struck me in that spring 2013 issue of **Box 459?** "**Who Does Prison Service Help?**"

Here is the text of that article – courtesy of the hard working staff at AA's General Service Office:

### ■ Who Does Prison Service Help?

Taking A.A. meetings into prisons, jails, and institutions has been a primary focus of A.A. service throughout the Fellowship for many years — and one greatly appreciated, not only by inmates inside who need the message and those outside A.A.s who are willing to bring it in, but quite often most notably by those nonalcoholic professionals charged with running such institutions.

What to do with alcoholics has long been an issue for professionals in the corrections field, as this April 1963 excerpt from the Grapevine article "Keep A.A. Alive in Our Jails!" by Austin H. McCormick, former nonalcoholic Class A trustee on the A.A. General Service Board, expresses: "There can be no denying the fact that American jails are places into which little light ever penetrates.... In most of the county jails of the country, no ameliorating influence of any sort, no application of either humanity or science, no effort to salvage the inmates is ever seen, with one exception — when A.A. comes in and stays in.... A.A. has brought some light into this dark picture, and must steadily bring more and more."

It is a sentiment similar to that expressed by Clinton H. Duffy, Warden of San Quentin Prison, one of the first penal institutions to open its doors to A.A., who wrote about that adventure in a 1942 paper titled "A Prison Program for the Rehabilitation of Alcoholics": "It was with some trepidation that this was done. We knew very little about the organization or how it could be adapted as part of our rehabilitation program. None of the Prison Administration were associated with A.A. We were therefore forced to go into the matter without benefit of any experience whatsoever."

As the experiment proceeded, wrote the Warden, "Into the room comes a group of outsiders — smiling, happy, well-dressed men, some of whom had motored from distances as great as 100 miles from the prison. One by one, these men told the inmates, in words that only real alcoholics could use and understand, of their experiences with the program which was being studied.

"The Chinese say a picture is worth one thousand words. That was a picture. For the inmates it meant a new vision of real help when they needed it most, before the first drink, for these men were not preaching something out of books. They were pouring out their hearts and souls. They were not preaching. They were assuring and re-assuring.

"I attended many of the meetings. I heard Mr. Anonymous Lawyer, Doctor, Banker, Truck driver, Ship fitter publicly acknowledge his former state of absolute degradation. I heard him state he had been able to regain his self-respect and the respect of his fellow citizens as a result of the influence and application of the program our men are studying, together with a fellow Alcoholics Anonymous member. I received letters from men and women offering to help in any way to rehabilitate an Alcoholics Anonymous member of San Quentin. Their offers were active promises, fulfilled whenever called upon....

"The unselfishness of the A.A.s is an inspiration not only to the inmates of the institution, but to the Prison Administration as well. Their wholehearted cooperation has enabled us to expand the program here in California. Recently the first inmate secretary of the A.A. group in San Quentin volunteered for transfer to Folsom Prison, the maximum security prison in this state, in order to organize an Alcoholics Anonymous group there. It is contemplated that similar groups will be started at the California Institution for Men at Chino, California, in the near future, for we here in California believe we have found the solution to one phase of our problem of rehabilitation."

Simply put, prison service helps us all.
