**Step 7** - Humbly asked him to remove our shortcomings.

**Tradition 7** (long form) - The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

Concept VII- The Conference recognizes that the charter and the bylaws of the general service board are legal instruments: that the Trustees are hereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purpose for its final effectiveness.

**Remember AA's Tradition 1:** "Our common welfare should come first; personal recovery depends on AA unity."

### District July Meeting Highlights

Pat L. attended our District 13 meeting this past Wednesday 7/2. Thank you, Pat for your participation at the District 13 meeting for the 2nd time in six months. She reported on the AA World Services Board 6/13/14 Report and General Service Conference - the Conscience of AA U.S. & Canada wide. Highlights below....

- Work continues on the **2015 International Convention** registration brochures that are scheduled for an August 2014 mailing to over 64,000 A.A. members, groups and service entities around the world. [2015 International Convention to be held in Atlanta, GA July 2-July 5 2015]. **Convention Registration and housing will open on September 3, 2014** and members will be able to register online. Through the Registration process, attendees will be able to preorder A.A.W.S.'s 2015 International Convention Souvenir Book and Grapevine's 2015 Convention Commemorative Book. They will also have the option to subscribe to the Grapevine and La Viña. [Recall that AA International Conventions are held only once every five years; the last one - 2010 in San Antonio, TX - had over 50,000 AA Members attending.]

- On June 2, AA's General Service Office [GSO] celebrated the successful launch of its newly redesigned website [www.aa.org](http://www.aa.org) and the accompanying mobile site. As Area 48 Delegate Pat L. pointed out at our July 2<sup>nd</sup> District 13 meeting, the new website is really easy to use and has a wealth of information for AA Members.

- Digital Publishing Program – Following the General Service Conference, the digital publishing program has added new titles from our literature catalog and has seen steady sales. Currently, *Alcoholics Anonymous*, *Twelve Steps and Twelve Traditions* and *Daily Reflections* (in English, Spanish and French) are published on Amazon, Barnes & Noble and Apple iTunes stores. *Living Sober* is scheduled as the next title to be published in the three languages, to be followed by *Came to Believe*.

It was voted on a motion made to begin holding district meetings monthly beginning in September.
