### 10/7/2015 Meeting Note not included in the October Newsletter

- Area 48 Chair Bill W. attended October 7<sup>th</sup> District meeting, summarized recent Area 48 service activity, thanked District 13 for its active AA service work, and described what AA service has meant to him in the quality of his own daily journey in sobriety.
- Voted/authorized \$111 expenditure for purchase of AA 'teenager/young people' literature [pamphlets] and professional [school guidance counselor] pamphlets & postage for CPC/PI Chair Karen H. to include in the upcoming District 13 AA mailing to 43 schools in our District [jr. high schools, high schools & colleges]. This mailing also includes District 13 meeting lists.
- Voted/authorized \$100 expenditure for purchase of basic AA pamphlets for Treatment Chair Lisa A. to refill District 13 AA literature racks at local treatment & other facilities including Glens Falls Hospital. These racks also contain District 13 meeting lists.
