- What is a Conference Advisory Action? Does our home group’s G.S.R., D.C.M., area delegate report back to the group on the highlights of the Conference and Conference Advisory Actions?
- Is our group meeting its wider Seventh Tradition responsibilities?

February 2011 Alternate Chair Report

In November 2010 we had a DCM meeting at the Fellowship Day in Districts 9/12. At this meeting we continued an ongoing discussion about locations and costs for upcoming Area functions such as Assemblies and Fellowship Days, in an effort to contain costs and also make the functions more accessible to as many AA members as possible. An outcome of this meeting is that our May 15, 2011 Assembly will be held in Amsterdam, NY, and hosted by District 4 with support from the other districts in that cluster. The Fellowship Day to be held in June will be hosted by Districts 9/12, and held in the Lake George Area, certainly an innovation in our Area. In March, the Corrections Connection will be held in Lake George on March 26, 2011. This is a joint effort of the Corrections Chair, the Treatment Chair, and the Functions Chair, cooperating to bring you the best Corrections Connection possible. Flyers will be available with all the pertinent information. The March 19, 2011 Fellowship Day will be in the Hudson Valley Cluster hosted by District 7. Flyers are available. The April 16, 2011 "Day of Sharing/Delegate's Day" will be hosted by District 5. Flyers will be available.

Our HMB Area will be hosting the New York State Informational Workshop this year. The date will be August 19-21 2011. This is a state-wide event which rotates among the 4 Delegate Areas in our State. This event was originally started in our area in 1980, as a one day event with an emphasis on PI and Institutions. It became a weekend event, and with an increasing number of attendees from other areas, the four areas agreed to rotate it around the state. It has expanded to include PI, CPC, Corrections, Treatment and Special Needs committees, as well as Archives, Grapevine, and Literature, and we include participation of the BTG committee (we are the only area that has a separate BTG committee and Chair). Last year there was much interest in the "Technology in AA" panel, and we expect to expand on this. We also have very active YPAA's in our area and we will welcome their participation. The workshop will be held at the Carondelet Hospitality Center at St. Joseph's Provincial House, 385 Watervliet-Shaker Road, in Latham, NY. We have verbal confirmation as of January 21, 2011, that we have that location and weekend confirmed. We still have to sign a contract stipulating prices and use of the facilities, and negotiate a price for lunch for the "locals". Organization and planning meetings will begin shortly. As Functions Chair, I am chairing the overall event, and Bill C will be registration chair. We will need many more key people to handle all aspects of this, and the Chairs of the standing area service committees will be fully involved in the planning process for the program to include roundtables, panels, workshops, and displays. A flyer announcing the date and location is now available for the purpose of getting the word out. The actual registration flyer will be out as soon as we have a PO box address for registrations, as well as checking account. At that time, prices will be available for those staying for the weekend as well as locals who will be commuting. This is a weekend service event which is for any and every AA member to attend; certainly for the area service committees, and the district committee chairs, as well as any AA member interested in any aspect of AA service. We will welcome anyone interested in being involved with this weekend event. We will need greeters, volunteers for the hospitality room, help with the registration table, planning the program, moderating, being on panels. Flyers at events and in the newsletter will keep everyone updated on all the 2011 functions and events.

Important Message from the Area

The Seventh Tradition (long form)

The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

Dear Trusted Servant,

We are writing today to remind the Districts, Groups and individual members of HMB Area 48 of the importance of contributions to the Area, and to urge you to be as generous as possible in these last couple and first few months of the year, when our expenses are highest. *Certainly, the most critical point to this letter is that at this time, the Area treasury is close to prudent reserve with many expenses coming up. In order for us to continue our service efforts, we are asking for your support. Please share this letter with your home groups and other groups in your Districts.*

We are excited about the many opportunities for service at the Area level. All of the officer and committee chair service positions are filled for 2010-11, putting us in a strong position to carry the message of AA to the still-suffering alcoholic. Through Correctional Facilities to Special Needs to Treatment Facilities, to name just three committees, the Area brings the message of hope to people who don't have ready access to the Fellowship.

The monetary contributions from the Districts and Groups in our geographically large Area are what make these services possible. The basis of all service – one alcoholic talking to another – cannot be valued in dollars, thank goodness, but setting up and running the service structure to allow that to happen does require contributions. It is where money and spirituality mix.

For the Area, the first two months of the year is when many of the largest bills are due. These include the semi-annual allocations to the Area Delegate and Area Chair to travel, attend conferences, arrange mailings and do the myriad other things required of them; paying once-yearly fees for archives storage, insurance and meeting book printing; and helping defray costs for officers and committee chairs to attend the Northeast Regional Alcoholics Anonymous Service Assembly (NERAASA), which vastly improves their ability to do their jobs.

NERAASA is a weekend of panel presentations and floor discussions on issues affecting Alcoholics Anonymous. Today, the Northeast Regional Trustee's Report, Saturday dinner followed by a A.A. Speaker Meeting. In addition, there are several Round Table Sharing Sessions throughout the weekend. They include (but are not limited to); General Service Representatives (GSR's), District Committee Members (DCM's), Archives, Cooperation With The Professional Community (CPC), Public Information (PI), Correctional & Treatment Facilities (CTF), Grapevine, Area/Panel Officers, Central Office/Intergroups, Website, Alternate & Area Delegates.

There are 18 regions in the Northeast Region. and we expect over 500 members from the 18 regions will participate. ALL members are welcomed and encouraged to attend!!

Saturday, January 22, 2011 (re-scheduled from Jan. 8, 2011)
DRAFT minutes

Agenda **attached**. A total of 56 attendees signed in at the event (Sign-up sheet **attached**).

Area Chair Keith D. called the meeting to order at 10:01 a.m., with a moment of silence followed by the Serenity Prayer.

Area Reports:

Deb D., Area Delegate, gave the **attached** report. Highlights include the preliminary agenda items for the 2011 General Service Conference; the 2011 Northeast Regional Forum; and a report on Group Status Listings (all **attached**).

Tad J., Alt. Area Treasurer, gave the following report (**attached**). This concerned mainly the ordering and production of the 2011 HMB Area 48 meeting schedules, which are due to ship in the last week of January. The total number ordered from the printer was 30,806, consisting of 128 separate orders. The Area ordered 3,000 schedules to have on hand for groups and districts to order during the year (order form **attached**).

Pat L., Alt. Area Chair, reported on various events and venues scheduled for 2011 (report, schedule and event flyers **attached**). The new site for the May Assembly will be at the Carondelet Pavilion, Guy Park Avenue, Amsterdam. The new June Fellowship Day will be held at Lake George.

William T., Secretary, presented the draft minutes (**attached**) of the Nov. 21, 2010 Fellowship Day. Motion (Lori W./Dave S.) to accept minutes as presented **approved** unanimously.

Chris S., Treasurer, presented the December 2010 Monthly Treasury Report; the 2010 Year-End Treasury Report; the whole-year 2010 Area Income & Expense report; Quarterly District Report by Month (Jan.-Dec. 2010); and Quarterly contributions (Oct.-Dec. 2010). All are **attached**. As of Dec. 31, 2010, the Area had a Treasury balance of \$9,891.60. Subtracting the Area's prudent reserve of \$7,000, the Area has \$2,891.60 in available funds. Motion (Joan R./Tom E.) to accept the Treasurer's reports **approved** unanimously.

HMB Area 48 Area Inventory Day Draft Minutes (Continued)

Keith D., Area Chair, reported the following open Area service positions: Alternate Secretary/Registrar and Web site Chair. A programmer-type person is desired. He asked attendees to put out the word about these openings. He thanked the committee, headed by Tad J., that put out the 2011 Meeting Schedule book. Also in his report (**attached**), Keith said there is still time to register for NERAASA 2011; gave updates on the ad hoc committees on Functions and on the Area Service Manual; and asked if anyone had a lead for a new PA system for Area events.

Don S., Chair, 2010 HMB Convention, reported that the November 2010 convention, with 248 pre-registered guests, had \$18,255 in gross revenues, \$13,648 in expenses. Of the net, \$2,000 is returned to the Area Treasury as seed money, and an additional \$2,400 in "profit" is given to the Area. Under Area Guidelines, 50 percent of that amount, or \$1,200, will be contributed to the G.S.O.

Joan R., Chair of NERAASA 2012, hosted by HMB Area 48 in Albany, NY, presented a preliminary list of committee members (**attached**). She asked that members take information to their groups and districts and solicit for volunteers. Anticipated attendance is 600-800. An email for the event was announced: NERAASA2012@gmail.com.

At 11:05 a.m., the Assembly broke into small groups for **Committee Roundtables and DCM meeting**.

Lunch was served from 12 to 1 p.m.

Area Inventory

Keith D. called meeting back to order at 1:02 p.m. Before starting the Area Inventory, Keith had the following announcements: Eric E. has agreed to serve as Alternate Newsletter Chair; Two or three people approached Keith expressing an interest in the Web site chair position; and Don S. agreed to be Alternate Corrections chair. Keith introduced **Past Delegate Dave S.**, facilitator of the Area Inventory. Dave S. instructed the Assembly to break into the various service areas and meet in roundtable discussion for one hour, with another hour reserved for report-backs.

Area Inventory Report-backs:

Treatment & Corrections (Don S.): Facilities throughout the Area are being served, which is excellent. The problem is that we have not found a way to actually quantify how many and which facilities are getting A.A. services, because it's hard to get data from individual Districts. Not all Districts have Treatment & Corrections chairs reporting to the Area. Better communication needed – that's where we need to focus energies. Members urged to contact Don S. at (518) 521-3223. It behooves DCMs to provide lists of all treatment and correctional facilities in their Districts, what activities are happening, and report that to the Area.

Newsletter (Ritch L.): The newsletter is comprehensive and informative about the many Area events and activities and is getting wide distribution. The main challenge is cost (more than \$6,000 for printing and postage in 2010). A solution would be to make the newsletter digital *only*, as a default position, unless a recipient specifically requests a mailed copy. Deb D. will summarize the Delegates' discussion on electronic communication, and how it applies to the Area 48 newsletter.

HMB Area 48 Area Inventory Day Draft Minutes (Continued)

Grapevine (Maria): Report (*attached*) detailing recent activities and successes of the Grapevine Committee: staffing tables, ordering new literature, promoting paper and online subscriptions.

Bridging the Gap (Erin): BTG forms are getting out to people. However there is not a lot of knowledge or information about what BTG is or what BTG does. There needs to be more electronic communication. Does every District have a BTG chair? Critical to meet the bus, the minute a person steps out of jail or rehab, and to have a meeting planned. Make rounds frequently to facilities, and remind them to keep Bridging the Gap forms always stocked.

Cooperation with the Professional Community (John D.): Again, communication is the key. Importance of maintaining lists of volunteers who staffed tables at previous health fairs and conferences, so that they can be readily called on to staff this year's conferences. Push CPC literature at meetings, pamphlets on what AA is and what it is not. Stronger outreach needed to hospitals and schools, which are usually happy to welcome AA volunteers but are less likely to seek us out. Mine the knowledge of existing professional events. Make greater use of the Area Web site, get a CPC page up. There is a disconnect among Groups/Districts/Area. People are hesitant to get into CPC, thinking they'd like to keep their service at the group level. At the same time, they would enthusiastically volunteer to carry the message to professionals. Without CPC service, however, they won't know when and where to do that.

Special Needs (Lori J.): Inventory report *attached*. Area Special Needs Committee needs a better contact list of District Committee Members. Districts – PLEASE share with Area what is going on in your Districts. The Area Special Needs Committee is addressing many needs: physical, hearing, visual, veterans, PTSD, remote communities, brain injuries, literacy. Area Special Needs Chair to visit District business meetings.

District Committee Members (Tammie E.): Again, communication. In this case, the importance of sitting down with new GSRs and other new committee members, and mentoring them on how the service structure works. It must be more than handing them a booklet or packet of orientation materials. Keeping ego out of service, taking the "question" out of service. Education is the key to retaining new GSRs, so they don't get overwhelmed and don't come back. Serve food.
